

GREATER HARTFORD'S TOP LAWYER

Who hasn't been treated to one of life's little curveballs—taxation troubles, an auto- or work-related injury, divorce or custody issues, a lawsuit, civil or criminal charges, or having to defend your company from a not-so-friendly takeover?

And then there's the good stuff—buying a home, setting up a business, establishing a family trust, registering a patent, or merging your company with another firm in an arrangement that benefits both.

In these situations and many more, finding the best lawyer to meet your particular need can mean the difference between a great outcome and a mediocre or even poor one. A good lawyer can not only make overwhelming circumstances seem manageable, but provide sound advice, offer solutions you may not have considered, and keep your worst nightmares from becoming reality.

Still, unless you're well-connected in the business or legal community, finding the best lawyer can be a daunting task—even moreso when you needed that lawyer yesterday.

That's where *The Best Lawyers in America* comes in. Published by South Carolina-based Woodward/White Inc. since 1983, this list of the nation's top practitioners serves as a peer-based referral guide to the cream of the legal crop.

This year's 2007 edition lists attorneys in 78 specialties and all 50 states, and was produced through an "exhaustive survey in which thousands of the nation's top lawyers confidentially evaluate their professional peers," according to Will Brooks, director of communications for Woodward/White Inc.

Formerly published every two years, the list became an annual publication as of this year.

The 2007 Greater Hartford list includes 188 different lawyers, representing 38 specialties ranging from alternative dispute resolution, bankruptcy law and criminal defense to securities law, trusts and estates, and workers' compensation law.

And how are the best lawyers chosen?

Brooks explains that the methodology has remained unchanged since the list was first compiled more than 20 years ago. The nomination pool for 2007 includes lawyers on the previous year's list, those who have since been nominated, and new nominees solicited from listed attorneys. The final determination of which lawyers are, and are not, included is based on a vote of their peers.

Lawyers nationwide were asked, "If you had a close friend or relative who needed a ... lawyer, and you could not handle the case yourself, to whom would you refer them?"

Voting attorneys were permitted to offer detailed comments on nominees, and that information was factored into the final selection process.

Brooks stresses that the process is neither a popularity contest nor a commercialized venture.

"Listings cannot be bought, and no purchase is required to be included," he says. "In this regard, *Best Lawyers* remains the gold standard of reliability and integrity in lawyer ratings."


He adds that while the listings inevitably reflect some subjectivity on the part of the voting lawyers, "the breadth of the survey, the candor of the respondents, and the sophistication of the polling methodology largely correct for any biases. For all these reasons, *Best Lawyers* lists continue to represent the most reliable, accurate and useful guide to the best lawyers in the United States available anywhere."
